The Speed of Thought.

Some recent investigations on the subject are thus summed up in the American Journal of Arts and Sciences: "Sensations are transmitted to the brain at a rapidity of about 180 feet per second, or one-third the rate of sound; and this is nearly the same in all individuals."

"The brain requires one-tenth of a second to transmit its orders to the nerves which preside over voluntary action; but this amount varies much in different individuals, and in the same individual at different times, according to the disposition or condition at the time, and is more rapid in the more educated attention."

"The time required to transmit an order to the muscles by its motor nerves is nearly the same as that required by the nerves of sensation to transmit a sensation; moreover, it passes nearly one hundredth of a second before the muscles are put in motion."

"The whole operation requires one and one-fourth to two-tenths of a second. Consequently, it is not a slow, cold, or apathetic, it is not a mere act of reflexion, but an absolute and certain fact, and an absolute distinction, with varying gradations, really exists."

Railroad Track Inspection.

Boston has a new dynamo car which while running at the rate of twenty miles an hour, discovers and marks out defects in the track of every nature, so that the track-walker's attention may be directed to the spot, and the defect remedied. It shows the side irregularities of the rails, gauges the height and frog, and the alignment of the track, elevation of either rail on curves and speed of the car. It mechanically sums up into feet and inches the various surface undulations of the rails as the car passes over the track and records the same. The car weighs twenty-six tons, and thus discovers many loose joints which would otherwise escape the attention of the trackmen until the rails become permanently bent and warped. The locomotive is worked by the Boston and Albany Railroad. The car has just been inspected and found in a very good condition. One end of the car is fitted up as a living apartment, in which the inventor finds comfortable quarters while traveling over the country inspecting the various roads. It has just completed a tour of inspection on some of the largest Western and Southern railroads, all of which respect the services of this or a like apparatus in order to perfect their tracks.
