

McKinley's First Annual Address to Congress.

Finance Question Next.
Tariff legislation has been revised by the extra session of congress, the question of the tariff for the sugar and tobacco duties has been the subject of much discussion. It is expected that the tariff for sugar will be reduced to 10 cents per pound, and that for tobacco to 10 cents per pound.

Many Plans Are Proposed.
