Assistant Prosecutor Gillespie Announces Candidacy

Is Now in Charge of Prosecutor's Office

To the Voters of Oakland County:

Some few days ago through the columns of this paper if announced my candidacy for the office of Prosecuting Attorney on the Republican ticket at the Primaries to be held August 29th.

As a word of personal introduction will say that I was born in the township of Addison, am 31 years of age, and have been a resident of this county all of my life. In addition to a public school education I am a graduate from the Law Department of the University of Midnigan, since which time I have been actively engaged in the practice of law at the city of Pontiac. During the past four years I have been associated with Prosecuting Attorney/Frank L. Doty as his assist ant, and have participated in the handling of over 3,000 criminal cases, including the preparation and trial of all of the criminal cases in the Circuit Court during that time.

It was my hope to have made a personal canvas of the voters regarding my candidacy, but owing to the fact that Mr. Doty has been called involve the United States army, the duties of this important office fall upon me as Assistant Prosecuting Attorney and command substantially my entire time.
