When in the summer of 1920 we could not at times take a bath, flush a toilet or even take a drink; nor could we water flowers or shrubs, and a large houseful of us were suffering.

The engineers told us a high up tank for storage would be used because our pumps were located so low down in the valley. What with lifting the water out of the tanks from 15 to 25 feet, and pushing the water up the hill to the uptown reservoir, the water was so scarce.

When, in case of fire, for instance, our mammoth storage tank is opened into the pumps and the lifting from the wells ceases our present engine equipment will throw the water higher and with greater force than can be secured by a high up tank even if its top is 120 feet above uptown ground level.

There has been no break-down of our system this year as was desired and expected by some people. Nobody had complained of a shortage of water although the citizens had been told to use all they wanted.

With twenty-four hour pumping and "sprinkle as you please" we were getting along without a complaint of any shortage. We were spreading the use of water over the whole day and taking the water out of the ground all the time.

There were no complaints anywhere. Then came an ordinance limiting hose use to two hours per day. Why? No shortage anywhere, but we must have a "shortage." It suits somebody to advertise the town as having a "shortage of water." We must have it, we do not want it. The flowers and shrubs and trees die but we simply must have a "shortage," so if you cannot get all the water you want to use in 24 hours, why not let us may save the other 22 hours.

We may let the plant low while our flowers and shrubs die but we may save the other 22 hours. Why do we not study how to use our water supply properly? Are we going to use this method to force a big bond issue? W. D. CLIZBE.
