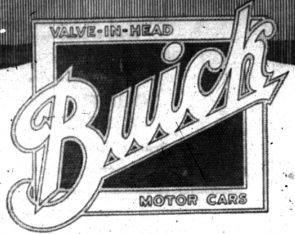




CHRYSLER LOWERS HILL CLIMB RECORD

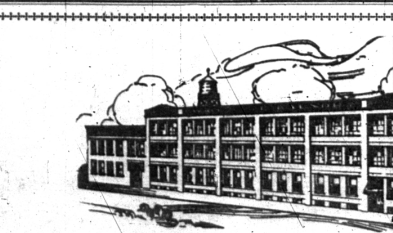

Cutting of Nonuser Woods

It shall be the duty of the commissioners of highways in each road district to give notice to every person or occupier of land in every parcel of land in that district or portion having charge of any lands in this State, whether the same be owned, managed, or by or through which land a highway or road is or may be constructed, to cause to be cut and cleared from such lands any woods, four inches or more in diameter at the base, and not less than two inches in diameter at the top, which are not needed for any purpose connected with the highway or road.
