### \$200,000 BLAZE IN PONTIAC MONDAY

Birmingham's new fire pumper, accompanied by a number of local firemen, spent most of Monday night assisting Pontiac in fighting a con-

flagration that completely demolished the grocery warehouse of Whitefield, Walters & Dawson at Garland and West Pike streets. The loss, estimated at more than \$200,000, was said to be practically covered by insurance.

Thousands of people were attracted to the scene of the blaze, where 11 streams of water were necessary to get it under enough control to prevent spreading to adjacent buildings. No definite cause of the fire has been ascertained.
