BONSTELLE PLAYERS TO GIVE "LIGHTNIN'" NEXT WEEK

The combined work of Winchell Smith and Frank Bacon, the latter creating a character that had lived in his heart for years, will be the offering of the Bonstelle Company at the Playhouse this week, beginning Monday night, August 10th.

It is scarcely necessary to mention the title of the play, "Lightnin'," with Lightnin' Bill Jones, a man of mellow simplicity, who, through accident and a colossal assumption of knowledge, to say nothing of a prediction for the following week, is dominating the entire story and play. This is the role created by Frank Bacon, who originally conceived the story and won a niche, in the "forever memory" before he departed. This role will be played by Howard Cameron, the new leading man with the Bonstelle Company, one which will afford him a further opportunity to display his versatility.

"Lightnin'" has the zest for its setting—a part of the dividing line between California and Nevada, with a boy of fair and talkative, divorce candidate as the backbone of the more human people Mr. Jones chose to people his story. Mrs. Jones is a woman of the hotel on the dividing line, while Lightnin' Bill, the husband, is the porter and "silly man" when he can be found and is a disposed.
