There will be submitted to the qualified electors within the boundaries of said "BLOOM-FIELD HILLS" the Question of Incorporation, in accordance with Act 278 of the Public Acts of Michigan for the year 1909, being Compiler's Section 2843 and Sections following, of Compiled Laws of Michigan, of 1915, and Acts Amendatory and supplementary thereto, submitting to the qualified electors residing therein,

The territory proposed to be incorporated is described as follows:

"Commencing at the Southwest corner of Section 22 in the Township of Bloomfeld, Oakland County, Michigan, being the corner of the Quarton Road and the Lahser/Road, thence running North along the West boundary of Sections 22, 15 and 10 to the Northwest corner of the Southwest quarter of Section 10, being corner of the Lahser Road and Hickory Grove Road, so-called, being the North line of the South half of said Section 10 to the East line of Section 10; thence East along the North line of the South half of Section 11 to the East line of Section 11; thence South along the East line of Sections 11, 14 and 23 to the Southeast corner of Section 23; thence West along the South line of Sections 23 and 22, being the Quarton Road, so-called, to the place of beginning, containing approximately five square miles."
