**PLUMBING BUREAU REPORTS**  
DROPS, FUTURE REPORTS  
Washington, June 19.—Plumbing fixtures essential to the six-week house are declining in cost according to wholesale prices reported by the Department of Commerce.  
At this period in 1923, the price of fixtures averaged 80 per cent above the level of 1913. Last year the average was 68 per cent above 1913, while at present it is 61 per cent above 1913.  
The index figures on prices given here are based on wholesale quotations of such representative articles as bath tubs, wash stands, range boilers, sinks and laundry tubs.

**Royal Oak To House New Phone Building**  
The beginning of work this week on a new \$225,000 telephone exchange building in Royal Oak was cited Saturday by Arthur F. Bassett of Bassett & Smith, Inc., as an indication of that city's growth.  
There are 4,650 telephones in Royal Oak, said he. "The plans of the new building provide for the ultimate installation of 12,000 telephones. The building will cover a piece of land 120 feet square and will be two stories high."  
"The continued rapid growth of Royal Oak and its neighboring municipalities out Woodward Avenue led last week to the appointment by Mayor Harold E. Storz of a municipal committee to consider the feasibility of a hospital for Royal Oak. The nearest facilities at present are in the Highland Park General Hospital."

**181 New Firms Are Organized**  
New companies incorporated in Michigan in May numbered 181 and had an authorized capitalization of \$19,893,000, according to figures compiled by the American State Bank of Detroit and released through John J. Barkin, president.  
The number of new corporations formed continues the rapid rate which has been maintained since the first of the year, and covers 238, 191 new concerns formed in April with an authorized capitalization of \$12,621,000, and 240 in March, capitalized at \$11,323,000. Approximately 950 new companies were formed during the first five months of the year, having a combined capitalization of close to \$65,000,000.
