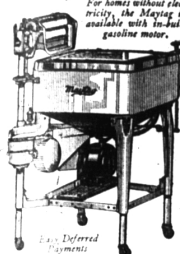


Local Man Remembers The First Telephone

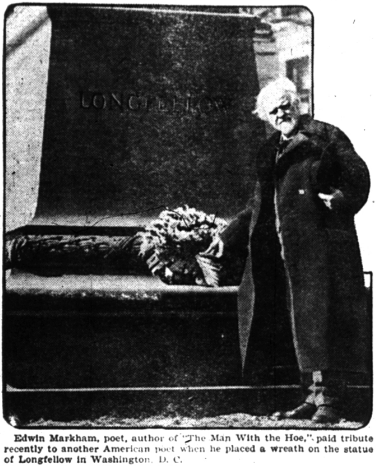
