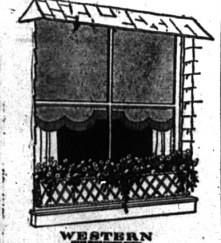
The money value of construction contracts let in the United States in the past week was \$33,583,000, against \$31,144,000 in the corresponding week a year ago.
