coln avenue will also be paved by the Taylor Construction company. Their bid of \$76,690.75 includes all the work.

Their bid for the three streets which were under discussion Saturday was \$42,625 while the bid by Olson for the asphalt pavement was \$31,045.20.

The work can be completed within two months, it is estimated.

Seven bids were received in all by the commission for the work.
