

### BRICK BUILDING WILL LEAD COLOR

Children's Room One Of Many Features Of New Structure Planned

NOTE: This is the second of a series of descriptive articles on the new building which will be completed on Martin street within a year. The eyes of the Birmingham stroller on Martin street one year hence will meet a sight that will be of the most varied and pride proud solid civic pride. For on the south side of Martin street, sitting well back in the midst of a green lawn, will be a dark red brick building with large windows, and a bit of a stone here and there, not a dark red brick building, particularly suited to the English style of architecture which will prevail in the library.

Behind the big double doors on Martin street, there will be two cubic entrances to the library, one at the rear, and one at the side. The former will be a children's entrance, and will open into a little hall by which children may reach the children's reading room or the story room without disturbing the occupants of the library.

The children's entrance will be opened only for the story hours until a special children's librarian is installed, who will be able to take care of that end.

The side entrance will lead directly to the auditorium on the mezzanine floor, and will be particularly convenient for attendants at lectures and such in this room.

In the basement, which will be about half the area of the building itself, there will be storage rooms where books will be delivered directly from the stores. A lift will come from the library floor at the rear of the first floor.
