New 'Indoor' Ball League Gets Under Way; Tennis Scheduled

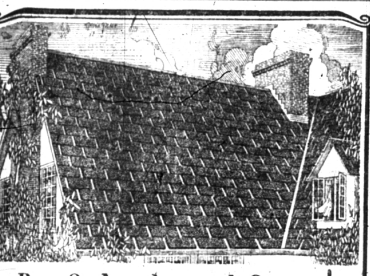
Behind Twilight church league baseball a soft ball league is started this week by A. Van Winkle, playground director.
