The duties of the committees to the sub-groups are set forth in the following words of the resolution as adopted:

"That the duties of each committee shall be to investigate and study the present conditions and future needs of their respective responsibilities, to acquaint the public, through the press or otherwise, of their findings, and to keep this commission well informed of the conditions as they find them, making up this committee such recommendations as each committee may deem necessary and advisable."

See Success in Move.
In presenting the resolution, Mr. Ellery declared it was the only possible way he could see that the seven-man board would function to the greatest of its ability.

"Many residents of the village are looking for either success or failure from the enlarged board," he said. "It is common knowledge that everyone's job is no time job. Hence I believe in this specialization."

"Several matters that have come before the commission at night could have been referred to the different committees had we already formed them. We could have had expert opinions to offer who presented the questions more familiar with their particular line of work."

Mr. Ellery pointed out that in suggesting the members for the different committees he had avoided placing persons in an embarrassing position. Those whose business would in any way be connected with the line the committee was investigating were on an entirely different committee, he said.

"Under this system we never can be charged with prejudice," he declared.

The resolution provides that citizens may be enlisted to aid the commission because he feels that a great deal of expert advice may be obtained this way, Mr. Ellery said.

Study Measure 3 Months.
Both the commissioners who voted against the measure declared

ed they felt that they had not yet had time to consider it. Mr. Ellery said it was not a new idea with him and that he had been giving the matter his attention for placing the different members on the committee was optional, he declared.

Mother of Luther Allen
Mrs. Allen, who will be 87 years old Aug. 12, is the mother of Luther Allen, president of the Village of Bloomfield Hills. She was born in Birmingham in 1840, the daughter of Mr. and Mrs. David Pat- chett, and when she was one year old, moved with her family to the site on Opdyke road where the W. Nelson Whittemore residence now stands. She has lived in or near Bloomfield Township all her life, except for vacation spent elsewhere, and is today the member of longest standing in the M. E. Church.

She was taken into the church when she was 12, on probation for six months. Having in that time proved herself a worthy member, she was accepted. Probationers who did not prove worthy were marked off the church books at probation class met in Bloomfield Center until after they became confirmed members of the church.

The Old Bloomfield
Bloomfield Center was quite a place, then, Mrs. Allen said. "There was a shoe store, a grocery store, and a blacksmith shop. But they all dwindled away, until Bloomfield Center was no more than a name. I am glad to see it come back again."

From Fifty Hill to a thriving community of lovely homes, Mrs. Allen said, "Bloomfield has grown. I like to see it grow," she said. "I don't think it will ever become a terribly commercial place. Of course it can't keep the charm of the little town that was Fifty Hill; it has grown too much. But the Fifty Hill spirit has been responsible for the charm of the place as a home center, I believe. There is an essential goodness about Bloomfield that not many towns can boast."

The whole country today is in a mad pursuit of pleasure. We don't have to work so hard for our pleasures. We worked enough for one thing, so that our moment for pleasure were rare enough to make them enjoyable to themselves. Then we had skating clubs, singing clubs, and exhibitions of different classes in the schools. And we had our outdoor sports, too."

Horseback-riding, Mrs. Allen said, has been popular in Birmingham ever since it was founded. I loved to ride. It was a glorious pastime, and this section of the country presents so many beautiful places to ride. I love Birmingham and the Hills at the time of year. I don't think there is a livelier spirit in the state."

When she was first married, in 1860, Mrs. Allen lived in a log cabin on Long Lake road, just west of Woodward avenue. "Log cabins sound a bit more romantic than they actually are," she laughed. "We built a house very soon."

An unwavering belief in God and His Word is one of the great factors in right living, Mrs. Allen believes. "Too much pleasure and not enough religion has been the downfall of many countries before this," she said.

"One hundred years of service in the cause of Jesus Christ to Birmingham ought to provide you with an abundance of strength of the present as well as the future. Your church provides a religion that can save a man from sin and death; the history of religion proves that man has been saved, as a matter of contemporary experience, it proves that it does save, and as a matter of hope and faith, it furnishes the evidence that it will save."

This is what Rev. M. S. Rice, pastor of the Detroit Methodist M. E. Church told an eager audience at the Birmingham Methodist Episcopal Church at a five o'clock service Sunday afternoon.

Rev. Rice was brought here through the efforts of Rev. R. M. Atkins, who is heading the local church's program during its 100th anniversary observance.

Rev. Rice declared that the Bible offers solace and comfort to all who diligently read it; he stated that, as a person's life is sub-

ject to constant change, so are his thoughts, and that the reading of the Bible each time brought forth new revelations and new understandings.

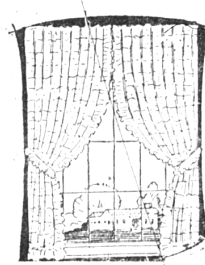
