HEALTH OFFICE KEEPS BUSY

New Department's Report Shows Increasing Activity

Work of the newly organized health department made considerable progress during the first month, according to a report in the hands of the village commission today.

As the result of inspections, several improvements are recommended. Conditions of dairies in Birmingham are favorable, the report declares, and restaurants are up to standard. Employees of restaurants will be examined and certificates given them, leaving their freedom from communicable diseases unimpaired. Dr. A. W. Newitt, health officer, contemplates asking the village to make a drive against rubbish scattered in various places. Milk samples examined last month numbered 36, Dr. Newitt's August report shows, and 4 water samples were sent to the testing laboratory. Two dairy inspections, 131 store inspections and 10 sanitary inspections were made by the health department last month.

(Continued From Page 1) ant in 1917 and sent to France, where, after serving as instructor and lecturer in an air training school, he was sent to the front where he served as captain in the air service until the end of the war. He received his discharge and returned to the law practice in Pontiac but still retains the commission of captain in the reserves. In 1914 he formed a partnership with George A. Gram of Pontiac, a well known in county.

Judge Doty is probably one of the best known men in Oakland county. He is chairman of the Oakland County Republican Party and was an important factor in the support of Gov. Fred W. Green in the last election. Besides being attorney for Birmingham since 1922 and of Bloomfield Hills Village since its incorporation, he is the attorney for every county office except the road commission. Approval of the board of supervisors and the county bar association was given wholeheartedly to Judge Doty for the post and he was recommended to Gov. Green from many other sources as the man for the appointment. He is a member of the Masonic order, of the 32d degree, and a member of the American Legion. His home is in Pontiac.

(Continued From Page 1) opinion from the commission that in some years Birmingham will have a fire station near Oak street and one near Lincoln avenue. There will be no need for one then in the center of the community, they believe. According to the first plans of the building, it would cover 100,000 sq. ft. of ground. Mr. Ellerby declared to the commission that the approval of the combined building is in the nature of a compromise so far as he is concerned.

Compromise Declared "I still think, and probably always will, that the fire station should be a separate building in the first block of the civic center. I favor the combined building because Birmingham is sadly in need of new accommodations for its fire and police departments and this seems the quickest and best way out of the situation." The commission had been deadlocked for several months on the issue and carrying of the resolution, presented by President Ellerby, was a surprise to many citizens who attended the meeting Tuesday night.

Briefly, the plans of the building called for the municipal office in the center with a wing on each side being devoted to accommodations for the fire and police departments respectively.

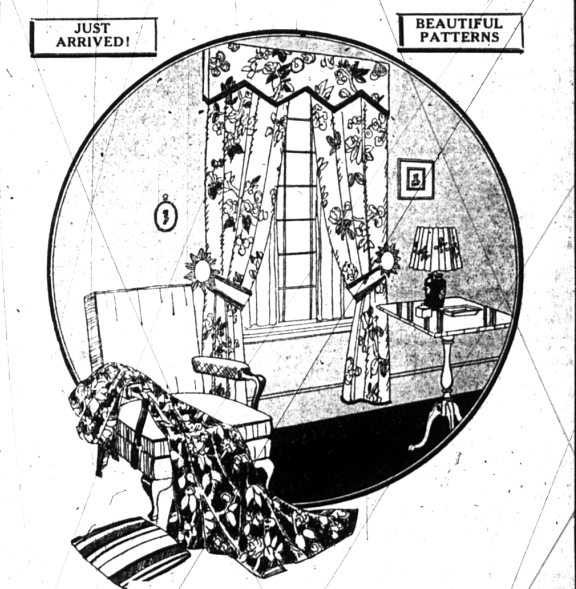

PARADE GIVEN BY NEW DAIRY

Horseless 'Wagon' Is Feature Of Downtown Exhibition

A horseless milk "wagon" to be used by the Birmingham branch of the Pontiac Dairy company, was the feature of the parade staged in downtown Birmingham Saturday by that organization to mark the opening of the new offices at 119-121 Brownell street.

The cartage is controlled by electricity and in time will replace the horse, officials of the company believe. It is capable of starting and stopping with a minimum of ease and is said to be economical to operate. Many of the white horses and wagons used at the Pontiac office of the creamery for deliveries loaned color to the parade and a large Detroit band gave the parade something of a martial manner as they marched on Woodward and Maple avenues.
