LINCOLN PAVING ACTION DROPPED

Commission Guided By Protest Of Property Owners

Paving of Lincoln avenue was definitely dropped by action of the village's commission at the meeting Monday night after a protest by property owners, begun some time ago, was continued. Efforts were made to obtain a writ in the special assessment for the work from the Oakland County road commission. While the commission said the county probably would share the cost, nothing definite as to amount could be obtained and the property owners believed the assessment, which would fall to them, would be too high. They have already paid their share of the coats of the graveling of the street and this work is to be begun at an early date, it is indicated. President H. T. Ellerby said he believed it would be better to pave the street but in view of the opposition from those who would be assessed, that the action of the commission was wise.

Alex J. Grosbeck's engineers was near \$2,000,000 but is now thought that it will not exceed \$6,000,000 and will possibly climb to \$10,000,000 if numerous damage costs awarded "adjacent" property owners are allowed. Both day and night shifts have been included in the men at work on the four miles of rights of way. Powerful floodlights are utilized to aid night work. The grading for the permanent track marks the greatest amount of excavation ever made in this section. Hills through which the new track will pass are as high as 50 feet and embankments from 5 to 25 feet are to be built for the rails' permanent bed. A yield of 450,000 cubic yards of dirt is reported to have already been taken from one cut made near Bloomfield Center and 6,000,000 cubic yards of dirt must be hauled over the temporary standard track which will be laid soon. The work is little more than off to a good start for after the grading is completed permanent tracks must be laid, the old top up to enable the wider Woodward grading and paving to be finished and to allow the superhighway to stretch in one continuous double ribbon after a lapse of more than four years since the first concrete was poured.

Under the terms, we would have the privilege of constructing a building of a certain prescribed type, of landscaping the grounds and of removing the land from the tax rolls. But our use of the land would be definitely limited. Mr. Walsh declared the lake would be available for the staking for villagers in the winter time and that the restrictions were placed on picketing to keep out boats to swim in the lake and that boating and fishing also are taboos.
