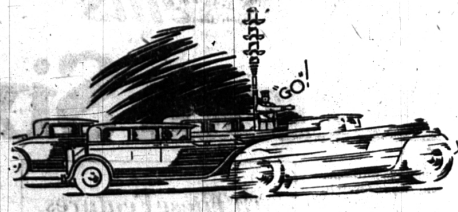
The Town That Time Forgot

ORDER SUGGESTION ON ORDER IS ISSUED ON THE SIXTH DAY OF OCTOBER, 1928, BY AUTHORITY OF SECTION 112, CHAPTER 21, PUBLIC ACTS OF 1927, MAKING A CLOSED SEASON ON MUSKIE IN THE STATE OF MICHIGAN.

IN THE STATE OF MICHIGAN, COUNTY OF INGHAM.—

An order was issued by the Conservation Commission on the sixth day of July, 1928, making a closed season on muskie in the State of Michigan, effective from the first day of March, 1929. It now appears that the order is beneficial to the public and that it is in the public interest to permit the taking of muskies during a certain period of the fall of 1928, and to continue the closed season on muskies on and after March 1st, 1929.

THEREFORE, the Conservation Commission, by authority of Act 232, P. A. 1928, hereby orders that, beginning on the 15th day of October, 1928, muskies may be taken, and that it shall be unlawful to take, hunt, or kill muskies on and after December 15th, 1928, inclusive, under penalties provided by Section 1 of Act 232 of the Public Acts of 1928.

This decision was made by the township board at a recent meeting. The application made by D. U. R. is for a 30-year renewal.

STUDENTS CONTEST FOR SCHOOL HONOR
