

CHICAGOAN PLAYS BELLS TOMORROW

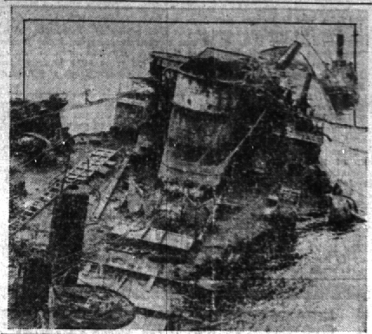
To Give Program At Christ Church In Absence Of Anton Brees
