Michigan's next governor undoubtedly will be Wilbur M. Brucker, 86-year-old State's Attorney General, whose victory in the contest for the Republican nomination was conceded early today by Burt D. Cady, campaign manager for Alex J. Groesbeck, Brucker's only formidable opponent. With returns from all but a score of precincts out of the 3,000 in the state, Groesbeck's supporters admitted defeat.

Brucker had piled up a majority of almost 90,000 votes when he came into Wayne County (early Wednesday). Groesbeck's strategy in the territory, however, made it appear that the race would be close and that Groesbeck would overtake the big lead.
