## \$395,000 BUDGET IS ADOPTED BY COMMISSION

### \$73,770 Decrease Over 1930 Expense Estimate Is Effected

#### LOWMAN VOTES 'NO'

With only one dissenting vote, the Village Commission at its meeting Monday night adopted a budget providing for expenditures during the fiscal year of \$395,000, a decrease of \$73,770 from the previous year's budget.

Adoption of the measure was accompanied with a statement issued by the Commission which declares that it has made a very material reduction in last year's expense of \$429,270 and yet has not made any material inroads on the standard of service which will be rendered to the community.

Although the village tax rate will not be definitely established until the meeting of the Board of Review late next month, the Commission's statement indicates that the reduction in this year's budget will mean a per capita tax of \$5 less than in 1929, and, if calculated on the same variation in effect in 1929, a decrease of \$1.10 per household.

**Then Original**  
The budget as adopted represents not only a significant reduction in the village's expenses, but also a material decrease from the proposed expenditures as outlined in a tentative budget drawn up by the Commission a few weeks ago.

The tentative schedule, which called for expenditures totaling \$403,620, was revised by the Commission on special recommendations of the Property Owners' Division of the Birmingham Real Estate Board.

The commission's statement takes cognizance of the action of the Property Owners' Division, commending it for its apparent interest in village problems and referring to its suggestions for reduction in the budget as having been "prepared and submitted in a spirit of co-operation and good will."

# 14 TEACHERS TO BE DROPPED FROM SCHOOLS

## Viet Announces Staff Cuts Due To \$168,000 Tax Delinquencies

### MUST BORROW FUNDS

Loss of revenue to the Birmingham village school system through the heavy tax delinquencies in the surrounding districts during the past year will necessitate a reduction in its school budget for the fiscal year 1933-34 which will result among other things, in the laying off of 14 teachers from the present staff.

Mr. Viet estimates that the deficiency from delinquent taxes will amount to approximately \$168,000 and that even with a proposed cut of about \$40,000 in the school budget, the Board of Education will be forced to borrow an additional \$100,000 to carry the system through the school year.

Although the new budget will not be drawn up until after July 15, it is already a certainty, Mr. Viet declares. The 14 teachers will be dropped from the staff, including two in the music department, two in the nurse department, and two in the physical education department.

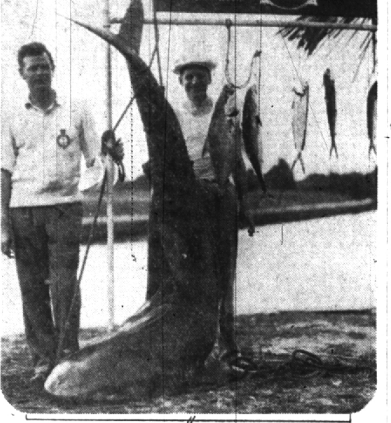

# Beware The Dog? No. Dogs Beware!

## Commission Decries All Dogs Must Be Confined For Next 60 Days

"Beware the dog" has been changed in Birmingham to "Dogs Beware!"

Beginning tomorrow and for 60 days thereafter, all dogs in the village must be confined by their owners to the premises of the owners and when taken out on the streets must be leashed, as the commission decreed by a six to one vote Monday night.

The resolution was offered by Dr. Fred L. Tucker and Commissioner Frank S. Packard was the only opponent of the resolution.

Complaints to the police department, to the individual commission members and to the village manager, prompted the action by the commission. Chief John A. Hervey reported that the police platoon reports which included an average of several complaints each day ranging from protests by parents whose children had been frightened to amateur photographers whose snapshots had been torn up by an annoying dog.
