

BLOOMFIELD FIRE TAX IS APPROVED

Establishment of a Bloomfield Township fire department was formally approved at a hearing on a special assessment roll held by the Township Board last Friday. No objections were entered against the roll, which is to be spread at the rate of 64 cents per thousand dollars of property valuation.

At this rate, the board expects to raise about \$8,500 which will cover the purchase of equipment and pay operating expenses for one year. The tax is to be spread against all property in the township outside the incorporated limits of Bloomfield Hills and Birmingham, with the exception of several estates in the Long Lake section, owners of which asked to be left out of the assessment district claiming that they do not need fire protection.

Possibility that the township's new department will be combined with the Bloomfield Hills Village department loomed at the meeting of the Bloomfield Hills Commission meeting Tuesday when Harry S. Starr, village engineer, was appointed a committee of one to investigate the advantages accruing from such action.

Mr. Starr expressed himself in favor of the combination, estimating it would save Bloomfield Hills \$1,000 annually in operating expenses.
