

ORDER OF CONSERVATION COMMIS-SION-DEER-COUNTIES SOUTH OF TOWN 20 NORTH

The Director of Conservation, having made a thorough investigation of conditions as regards the hunting of deer in the counties of the State south of Town 20 North, recommends a closed season.

THEREFORE, the Conservation Commission by authority of Act 230, P. A. 1925, hereby orders that for a period of two years from November 15th, 1931, is shall be unlawful to pursue, hunt, or kill or attempt to pursue, hunt, or kill any deer in the district comprising the counties of the state south of Town 20 North, which is the north line of the Counties of Arenac, Gladwin, Clare, Oscoola, Lake, and Mason excepting the Counties of Mason, Lake, Clare, and Newaygo, which counties are closed by Act 97, P. A. 1931.
