annual interest upon all unpaid interest to be paid by the commission...

Section 18. In all cases of special assessment of any kind against any property where any such assessments shall prove to be invalid...

Section 19. No judgment of decree, nor any act of the commission...

Section 20. When any special assessment shall be conferred, the city treasurer shall direct the assessment to be levied on the special assessment roll...
