Three Detroit theaters have attractions this week. Premiere of "The Bad Boy" comedy by Charles Bickford, of movie fame.

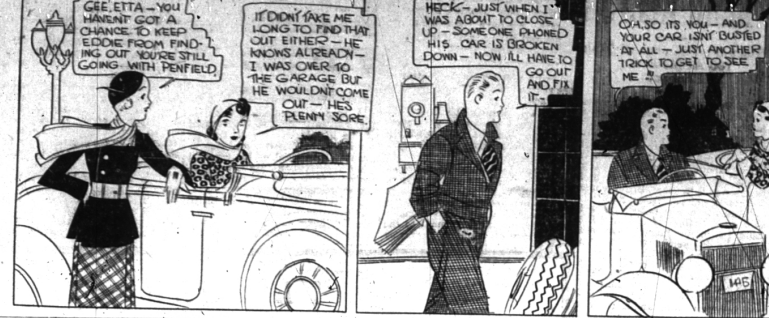
Another comedy, "Unexpected Happenings" by Harry Green, is showing at Lafayette, where price policy went into effect Sunday.
