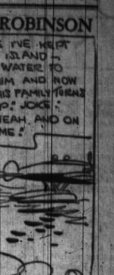

Commission Makes Vacation of Plat Contingent On Settlement of Delinquency... The City of Birmingham will make vacation of the land plat known as Sheffield Estates No. 1 contingent upon payment of taxes now delinquent on the property.

While the company's application for permission to vacate the plat was held in abeyance, the City Commission decided Monday to instruct City Manager James W. Parry to notify the owners to this effect.

The land is owned by the Goodrich Land Company, Inc. City taxes of \$19,944.92 are delinquent on the property, and \$48,333.59 in state and county taxes.
