\$23,000 DEPOSITS STILL UNCLAIMED

First State Bank Receiver Issues Comparative Statement Of Financial Condition

Claims have not yet been filed against deposits totalling \$23,800.99 in the closed First State Savings Bank, it was announced today by Charles W. Lee, receiver, in issuing a comparative statement of the bank's condition as of June 15, 1931, the date of closing, and Dec. 31, 1932. The complete statement will be found on Page 2.

Although notices have been sent to each depositor, several have still neglected to file their claims. Mr. Lee pointed out. All claims of \$10 and less are to be paid in full as ordered by Judge Frank L. Daily when he authorized the recent 5 per cent dividend on claims in excess of \$10.

Payment of the dividend necessitated the borrowing of \$5,000. Mr. Lee said, of which \$3,000 has been repaid.

The statement shows an increase of approximately \$33,000 in the assets of the bank in the account known as "real estate." This represents resident and farm property the title to which has been turned into the bank's hands through mortgage foreclosures. Mr. Lee explained. In fact, in the appraisal is made of the property when the title is received and it is either offered for sale or rent or for necessary repairs have been made. Only three houses in the bank's possession remain unrented at the present time, he said.

While less than 16 per cent of the assessment levied against the stockholders has been collected to date, suits have been started against several stockholders who had not made arrangements to pay their assessments. Mr. Lee announced.
