SCHOOLS LACK MORAL STRESS

Dr. Stevens Says Modern System Fails To Teach Right Conduct

The average school of today, along with the church and the home, has abdicated its duty—once well recognized but now almost totally ignored — of teaching young people the value of morality and decent conduct, in the opinion of Dr. William O. Stevens, headmaster of Cranbrook School.

Dr. Stevens addressed the congregation of St. James Episcopal Church Sunday morning as the last in a series of lay speakers and visiting clergymen who have occupied the pulpit in the absence of the rector, the Rev. Warner L. Forsyth. Mr. Forsyth, who has been away for the past three months because of his health, will resume charge of the services next Sunday.

Too often, said Dr. Stevens, do young people of today, warned against indulgence in lying, cheating, drunkenness and other vices, respond with the cynicism, "We only love one, so what's the harm?"

Warns of Collapse

"Unless the home, the church and the school can face that kind of questioning, and answer it successfully, we are threatened with a total collapse of all that is worthwhile in our civilization," the speaker declared.

He recalled that the earliest American textbooks, down to the McGuffey readers of post-Civil War days, consistently emphasized moral and religious values, performing the double duty of teaching academic facts and good behavior. Lately, he said, the tendency has been more and more away from the moral emphasis in textbooks, due partly to the misconception—or misapprehension—that it is irrelevant and unnecessary, and partly to the difficulty of teaching religious material in schools where a variety of faiths and denominations may be represented.

"The whole question of morals and conduct has had to be omitted from the public school system, which is, I think, a matter for serious consideration," Dr. Stevens declared. "It seems to me this is one of the most important problems confronting all of us in home, church and school. I wonder if the morality of the old textbooks has not been underestimated."

Describes 'Experiments'

In disparaging terms, he spoke of certain experimental schools whose sponsors consider them to be the last word in educational methods. Dr. Stevens visited some of this type of school on his trip to England this summer. Practically all of them, he said, are opposed to the teaching of religion because religion implies discipline, and discipline is not consistent with their instructional methods.

He referred to one such school in England which actually discourages church attendance on the part of its students, and another where the students, governing themselves, decided they would refrain from swearing in town, for fear the inhabitants might misunderstand, but that there would be no restriction upon profanity within the school itself.

This kind of education, he warned, may serve only to bear out the truth of John Ruskin's statement that students, under some conditions, are able to "turn their arithmetic to recsary, and their literature to lust."

Miss Doris Faer returned home Monday after spending a few days as the guest of Miss Grace Kirby in Detroit.

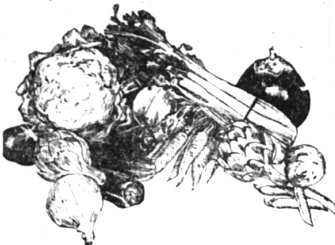
