GROSSE POINTE 3-Act Play To Be Staged Tonight At Baldwin High
The first school play that has been presented by Baldwin High School students in two years will be staged in Baldwin Auditorium at 8 o'clock this evening. The play, "Green Stockings," is being given by the Baldwin High School Dramatic Club with Miss Ruth Hull, the club advisor, as the director.
"Green Stockings" is a three-act comedy farce laid in London. The leading feminine character, a part to be played by Joanne Hart, is an unmarried, middle-aged woman whom love has apparently passed entirely by.
Upon returning from a week-end trip, however, she tells her husband that she has fallen in love with a certain Colonel Smith, and that he has returned her affection. Her story proves to be a fanciful one, and what transpires when the Colonel actually does meet her lady, and the incidents that befall the rest of the cast, furnish many minutes of first class comedy entertainment.
Miss Hart shares leading role honors in the play with Robert Mix. Others in the cast include Ralph DuBois, Lucille Hallett, John Parker, Roberta Chisum, Robert Vinton, Mary Quinn, Charles Dean, Bob Donaldson, Betty Wilson and Henry Foley.
With the price of admission the lowest they have been for a high school play here in several years, those in charge of the ticket sale have hopes of packing the auditorium to capacity. Three-fourths of the profit will be given to the junior class to finance the junior-senior reception, and the remainder will be placed in the Dramatic Club's treasury.
The stage setting is being modeled under the supervision of Miss W. Robinson, manual arts instructor. Miss Marvel Carson, a Baldwin alumna, is assisting Miss Hull with the direction.

BALDWIN RUNNERS WIN STATE CROWN
Mile Relay Team Leaves Two Feet Far Behind In Indoor Meet At Ann Arbor
Running against teams from Waukegan and Dearborn, the Baldwin High School relay squad easily took first place in the Class B mile relay at the State A. A. Meet last Saturday evening in Yost Field House at Ann Arbor. The Maple team, composed of Bob Savage, Don Donaldson, Clark Matthews and Bill Guckelberg, finished far ahead of the other two quartets, and was clocked in 3 minutes, 41.3 seconds for the course.
The time made by the Maroons was two seconds faster than the pace set by Flint Central, winner in the Class A division.
Two of the boys who ran Saturday will be unable to compete in track this spring. Matthews and Guckelberg were both graduated last week. Donaldson will be one of two track veterans from last season who will be eligible again this year. Savage was not a member of last year's track team.
