GROSSE POINTE BEATS MAPLES

B. H. S. Quintet Shows Little Improvement, Dropping 7th Straight, 27-14

Showing little improvement, the Baldwin High School basketball team went down in defeat before a superior five from Grosse Pointe High School today evening. Playing on their home court, the Millionaires led at the end of every period, and the final count stood 27 to 14.

It was the seventh straight Maple defeat, but it can hardly be said that bad luck is haunting the team or that its members are stale. The Grosse Pointe victory can be attributed almost entirely to the Maroons' poor play. Compared with last performance, the Maroons of St. Mary's of Orchard Lake, the Baldwin team Friday night was much better, and the Maple play will have to improve considerably more before it will account for many victories.

The Grosse Pointe quintet was the best the Maroons have met in the history of the Border City League, a loop that includes many good teams. Grosse Pointe has lost only two of its nine games this season and is considered one of the top teams in the state. A basketball coach.

The Millionaires were not as good as their reputation Friday night, but they were good enough to show up the Maples. Jim Garretson, point captain and center, who had averaged 10 points a game, scored only six points against the Maples. Paul Keller, right guard, also went without his usual goodly number of points, contributing only two units to the Pointe total.

At least the Baldwin team had the satisfaction of thwarting a play that had been a thorn in the side of every previous Baldwin squad that has played Grosse Pointe. Every year the Pointe quintet has used a body block with unusual effectiveness. Friday evening, against the Baldwin zone defense, this block, or "screen" as it is termed in the basketball rule book, proved of little value.

The first two fouls of the game were called on Pointe players who became over-anxious and moved into the path of a Baldwin player instead of waiting for the Baldwin zone to break. This screen, which discouraged the use of the "screen" and it was not included in the Grosse Pointe tactics for the rest of the game.

As the game progressed, the Maple squad, held previously this season by Bob Harris, who was not to be beaten through graduation two years ago, was handled by Jack Birchmont, who saw action in his first varsity tilt. Although he was far outclassed by Garretson, he showed some promise.

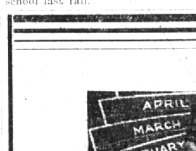
