

MONROE TOPS MAROONS, 25-17

Superior Height Gives Trojans Needed Advantage In Cage Tilt Here

A rangy basketball five from Monroe High School outpointed the Maroons of Baldwin High in the fourth game of the season Friday night on the Baldwin court. For three periods the Maroons battled to overcome the lead the Trojans had gained in the initial stages, but their efforts were futile and a 25 to 17 decision went to Monroe.

The largest single factor in the Trojans' victory was their height. No less than half of the Monroe

Maples scored four points in the first period before Monroe made a basket, but by the time the quarter ended the Trojans held a three-point lead, 10 to 7. At half time, the Monroe five had increased its advantage by another point and the score stood 15 to 11. Steve Burhart, Monroe left forward, made the only score of the third period when he tossed in a follow-up shot.

The preliminary game between the Monroe second team and the Baldwin reserves proved to be the more thrilling of the two contests. When the four periods of play had ended, the court stood knotted at 19-all. Perry Mason, Negro guard for the Monroe outfit, found the hoop for two field goals in the three-minute overtime period, and the Trojans also came out of this game the winners, 23 to 19. Red Howling, of Baldwin, was high scorer with 11 points.
