BITS ON BRIDGE
E. C. Whitney
Two-Way Three Bids
Last week we discussed opening bids, pointing out that the requirements, via verbiage or not, vulnerable, include a long, powerful trump suit and from seven to ten ace winners, the honor trick (worth of the hand determining whether the bid was a short suit suit or a "powerhouse").
Neither partner nor opponents know which kind of bid the opening bidder is making on the first round. However, the responder should be able to determine whether the bid was a short suit suit or a "powerhouse."
1. Pass if holding less than one honor trick. However, if you hold a singleton in a side suit and three trumps, raise to one regardless of honor strength.
2. Raise the three bid to four if holding one honor trick and two trumps headed by the Jack or better.
3. With from one to three honors and no bidable suit, respond with three no-trump.
4. Take out a minor suit (three or four) with the other in four or more honor tricks.
5. Overcall a minor in major three bid with the other in four or more honor tricks. Take out partner's minor suit three bid into four of a lower ranking suit, providing your hand contains a two or honor bid headed by a two of the three top honors and at least two and one-half honor tricks in the hand.
6. Jump to four of a major over an opening three bid or bid four Spades over three hearts only with a long suit suit of your own, such as AKQXX.
7. Bid four no-trump holding four honor tricks, including two aces and the bid king, of three aces.
All suit takeouts, when below game, are forcing for one round. If the opening bidder has a minimum hand and first partner with a minimum of one honor trick, he will be defeated two tricks after signing off at the level of four. But it must be remembered that the opponents probably have been cut out from a game contract.
