Heading a list of new books for young people at the Public Library is T. Miller's General Douglas MacArthur. The general's life from his West Point days to the present contains enough drama for a dozen novels, and the author of this biography makes the most of it.

Wings of Defense, by Captain Burr Lyson. A compact, up-to-the-minute book on America's air power. Particularly interesting is the section dealing with bombing and bombers, the differences between Army and Navy planes, and between fighter, interceptor and bomber planes.

Million-mile, by John R. Tunis. The true story of Jack Zimmler, chief pilot of one of the commercial air lines. Some of his experiences make some of the more lurid novels pale into significance and the author does them full justice.

Coast Guard Cadets, by Kenneth Nottel. The hero of this novel with a true background, is Jim Steel, a "Ice Patrol" fume. The present story is concerned with his three years at the famous U. S. Coast Guard Academy.

Carolina Caravan, by Christine Nottel. Adventure filled story of Kitty, orphaned at 16, whose determination not to be separated from her brother and sister led her to run away in secret, tricking to the South Carolina coast, where they could live for the summer. Their journey, and the adventure-filled summer make good reading.

S. O. S. Radio Patrol, by William Heyinger. The Radio Patrol of Troy 9 thought they were going to have a care-free camping trip. The river flooded and the camping trip became a grim business before they were rescued.

Clue of the Cipher Key, by Jane Selkirk. The young a male u leader of the "Lantern Jewel Case" find themselves in a really involved puzzle this time.

Hiddid Wings Mystery, by Alan Greig. A gripping story of the Mexican border-Patrol.

Canada Rations Gas At 24 Gallons a Year

In view of the increasing gravity of the gasoline shortage in Canada, due to the exigencies of the war, gasoline rations for tourists entering Canada have had to be drastically reduced.

A new order provides that if a United States or foreign car tourist wishes to stay in Canada long enough to need more gasoline than he has in the tank at the time he enters the country, he will be given at the port of entry a ration book permitting the purchase of only 4 units of gasoline. At present a unit represents 5 Imperial gallons of U. S. gallons, but its value may be changed at any time as circumstances vary.

2. Avoid the "peak" hours for your calls. The best times to call are before 9 A. M., 12 to 2 P. M., 4 to 6 P. M. and after 9 P. M.

3. Be sure you have the right number. Consult the directory. Please don't call information needlessly.

4. Be brief. Know what you want to say, and keep paper and pencil handy so that you won't have to repeat.

5. Speak distinctly, with your lips about an inch from the microphone, so that you won't have to repeat.

6. Don't telephone during or just after an air raid alarm or blackout, except in emergency. Keep lines clear for war calls.
