Oakland County RED CROSS NEWS

Mrs. Layton L. Northrup, 1040 Gordon court, chairman of nutrition of the Oakland County Chapter, American Red Cross, is making an urgent appeal to housewives of Oakland County to help fight the famine which is threatening the lives of hundreds of millions of people in foreign countries.

"It will be necessary for this country to continue to share its food supply for at least another year," she said. "Housewives can assist by food preservation. Wheat will be scarce for months to come. To safeguard diets it will be necessary to eat more of other foods. Vegetables are plentiful and many more of them will be eaten this year to replace some of the food values and 'filling' quality of the wheat that goes abroad."

The U. S. Department of Agriculture, Washington 25, D. C., has a number of bulletins available for distribution, among them "Home

Canning of Fruits and Vegetables" and "Home Canning of Meat." Also, "Home Freezing of Fruits and Vegetables" may be secured by anyone who wishes this information.

Mrs. Northrup also states America throws away the richest garbage in the whole world and that housewives can help to save by serving simple meals; avoiding the overloading of plates; squeezing out the gravy; tilting the bowl; picking chicken bones; serving sandwiches with crusts; refusing food that will not be eaten.

Marshall Smith, chairman of the Oakland County Chapter, American Red Cross, announces that Mrs. T. W. Eastis of Birmingham has recently been appointed Home Service Chairman of the local chapter, to replace Mrs. Sheldon Noble who has resigned.

Mrs. Eastis brings to this committee a number of years experience in this Red Cross service as she has been a Home Service Volunteer for many years. Originally serving as chairman of inquiry and information, Mrs. Eastis, during the war years, directed the sending of inquiries abroad as well as the delivery of messages locally. She is a member of the home service corps only recently having received a certificate for the basic training course.

The Volunteer Special Service will remain at its present address, 410 Pontiac State Building.
