

Student Council of Vaughan School Has Annual Elections

Friday morning at 11:15 the assembly for the nominating speeches was held. It was out-of-doors, on the front lawn, where the speaker's platform, and even adjacent trees, were gaily decorated with the party banners and streamers.

Many speeches had special features to amuse the voters. Joan Wood, speaking for Howard Rogers, the Bloomerist presidential candidate, composed a poem in his honor, and a song in tribute to the party. Dick Blake, the S. S. Party candidate, brought out scales to weigh the presumed virtues of the varied officers. Tom Tweedale, arriving by auto, was dressed as a southern senator, and made a "Senator Claghorn" appeal to his constituents.

The students voted during the noon hour, and when freedom from classes permitted during the afternoon. The election results, which were counted by the close of the school day, gave the Varsity party an impressive majority. One hundred and forty-three ballots were cast, of which slightly over one-third were straight party ballots. The larger number of split tickets is partly a tribute to

the activities of the committee in charge of the elections who tried to inform the students of the value of voting according to individual merit, rather than by party label.
