Charges Dem Fumbled Unemployment Problem

"The Democrats have fumbled the ball on the whole problem of unemployment in Michigan," Auditor General John B. Martin, Jr., charged Monday night at a meeting at the Community House. "Senator Moody and the Governor are now desperately trying to make a grandstand play to recover the ball."

The present crisis of growing unemployment was entirely avoidable, Martin believes, if the Truman administration had not completely miscalculated the scope and intensity of the defense program.

The situation has been growing steadily worse in recent months with repeated promises from Moody and Williams to do something about it and absolutely nothing done, Martin said.

NOW WE HAVE a proposal from Michigan's junior senator that the Federal government invade the whole field of unemployment compensation with the express purpose of putting pressure on the states to act contrary to the better judgment of the state legislatures in establishing their own unemployment compensation

programs. It is typical that he comes up with a plan aimed at the destruction of state authority and the surrendering of that authority by a federal program," Martin declared.

"The proposals appear to contemplate two levels of unemployment compensation," Martin stated, "one for those who are unemployed for ordinary reasons and a higher level for those who are laid off because of the war change-over."

"IT IS QUITE obvious," he said, "that any such double standard in unemployment compensation would create the most intense dissatisfaction and friction among workers and would operate as a gross discrimination against thousands of Michigan workmen in favor of some others out of work because of war shortages."

At the present time, he believes, the Michigan Unemployment Compensation fund is in good shape and there is no reason to think in the several states that need for unemployment compensation payments as these may arise. The Michigan program should be reviewed, he said, to make certain that it meets the present problems as regards exhaustion of benefits and other needs.

UNTIL IT IS clear that Michigan cannot handle its own problem, the federal government ought not to rush into the picture. If the problem appears too big for Michigan to meet from present funds reserves, the federal government may be asked to supplement what the state is doing. Such action should not create a double standard of compensation or subsidize those states which have done the poorest job in providing unemployment compensation for their workers.

"To ignore this principle would mean that Michigan taxpayers would have to foot the bill for federal discrimination in favor of states which are unwilling to take care of their workers as well as Michigan has done," Martin declared.

THE AVERAGE weekly benefit check for unemployment compensation, Martin said, is the highest in the country.

"The federal government must not be allowed to get control of unemployment compensation funds in the several states upon a program at the expense of Michigan in favor of 47 other states whose weekly benefit checks are less than ours," Martin concluded.

Martin, who is a candidate for U. S. Senator, was introduced by Richard G. Van Dusen, chairman of the meeting.
