## Lutheran Church's Proposed Educational Building



This architect's drawing shows the present church edifice (at left) and the proposed educational building of the Redeemer Lutheran church on West Maple, located at the rear and east of the present building. Work on the new building will be started as soon as conditions permit. It will contain nine Sunday school

rooms, three assembly rooms, and offices for the minister and Sunday school secretary. The addition will be 115 by 40 feet and the estimated \$150,000 building cost will include driveways and park-ing areas.
