Donald S. Leonard Cites Legislation Before AAUW

Choosing "What Do We Need in Legislation in Michigan" as his topic, Donald S. Leonard, Detroit police commissioner, spoke to 120 members of the Birmingham branch of the American Association of University Women, Wednesday, October 8, following their luncheon meeting at the Birmingham Community House.

Mr. Leonard, who is chairman of the permanent committee representing state law enforcement agencies is deeply concerned with the causes of crime and the need for legislative improvements.

"Public apathy or an attitude of indifference to public interest is one of our gravest faults. It is up to the citizens to see that the laws of the community are properly enforced. And, that public opinion is properly moulded."

"A good sound public interest is necessary for a regeneration of justice."

IN LISTING the causes of crime as he sees it, the commissioner noted four factors:

America is made up of people with varied heritages, with language, custom and tradition differences. This heterogeneous population is consequently not as predictable as a group stemming from the same background.

There are too many loopholes in our legal procedure. In many cases technical and lengthy litigation allows a reversal of trial of the release of a guilty person.

Juries are too lenient. Too many so-called "good citizens" duck their jury-service and thus juries are not always a cross-section representation of the public.

Unwholesome early associations, Mr. Leonard stressed that "It is important that young people realize that if they are in the company of someone who commits a crime that they too are guilty."

IN MAKING improvements, it has been suggested by some that the constitutional guarantee be changed. Mr. Leonard considers this "dangerous."

"The fundamental concept of justice," he said, "is that a person is innocent until proved otherwise. We must safeguard our individual rights. The United States stands alone among the great powers in having retained these."

The speaker made the plea that the AAUW pay close attention to the bills that are being introduced in the state legislature regarding law enforcement.

Mr. Leonard feels that the prosecuting attorney should be given the power to subpoena individuals without a warrant in order that he may get a statement.

The present bail of convicted persons should be discontinued. He cited the case of Fleischer and Selik who fled from the state, after conviction, while out on bail pending an appeal.

LEONARD ALSO cited legislation regarding registration required in Motels and camps as it is in hotels; the amendment on search and seizure; and a law requiring motorists to register with the state police. If it is proved that someone is a communist and he is not registered then he would be subject to arrest.

Leonard closed by again emphasizing that the alertness of a group or an individual to proper legislation and law enforcement is the guarantee of a good community.
