## For 18 long years you have had no election of Circuit Judges.

You have not been able to select Circuit Court Judges at an election as is your right under the Michigan Constitution. Why is this true? Frankly, because under our Law, only a Lawyer may be a candidate for the Circuit Court Bench. Able Lawyers generally have discouraged themselves from trying to unseaf any Circuit Judge, be he good or bad. Lawyers know it is about impossible to beat out a Judge at election when he carries the ballot label of "Circuit Judge.

State Senators Blondy and Hutchinson said at Lansing, February 25. 1953, 'A let of good lawyers would like to run for the Bench, but the incumbent designation on the ballot perpetuates those in office.

When these good Senators attempted to remove this unfairness from the Judge ballot, the Lansing News Bureau reported, February 26, 1953, as follows: "In the Sendte, pressure from Judges stymied a proposal to eliminate their designation as incumbents on the nonpartisan election ballot."

## It is time for a change.

Because a man is designated "Incumbent" or "Circuit Judge" does not mean he is best titted for the high honor and privilege of serving as Oakland County Circuit Judge. Mr. Beer respects the present Judges. So do I. But the citizens of Oakland County should have opportunity to vote for someone else as Judge if they desire. Several thousand citizens of Oakland County, by constitutional nomination, asked William John Beer to give them that opportunity. Mr. Beer has accepted their nomination. A JUDGE SHOULD BE PATIENT AND HAVE PLEASANT DIGNITY. Impatience has no place on the Bench. The people and their Lawyers should have the "cars" of the Court, but seldom his "voice. He must be sober and industrious on and off the Bench. He must be fair minded and courteous. For years he has been a member of the Domestic Relations Committee of the Michigan State Bar. He is yecognized as an expert in solving

divorce matters. Divorce cases involving the Nation's children are the largest group of cases brought before the Circuit Courts. WILLIAM JOHN BEER IS A FAMILY MAN, HE BELIEVES IN STRICTER COMPLIANCE WITH DIVORCE

WILLIAM JOHN BEER IS AN OAKLAND COUNTY LAW-YER, Although he was born in Detroit, Michigan, Mr. Beer is of a well-known Oakland County pioneer farming family. Stella (Loopey) Beer was his mother. He has an older brother. Edmund Beer, and a younger brother, Jim Beer, His father, Bert Beer, is remembered for his many years of work in the churches of Oakland and Wayne Counties as a vocalist and director of music. Mr. Beer was graduated from the Royal Oak High School. He now resides in South Oakland County at Berkley, Michigan.
