

(a) That the city shall have a security for the collection of such utility taxes and assessments... (d) With respect to the collection of rates charged for water the city shall have all the powers granted to cities by Act 178 of the Public Act of 1939.

Disposal of Utility Plants and Property: Section 13.5. Unless approved by the affirmative vote of three-fifths of the electors voting thereon at a regular or special election... Utility Finances: Section 13.6. The rates and charges for any municipal public utility for the furnishing of water, shall be so fixed as to at least meet all the costs of such utility.

CHAPTER 14 PUBLIC UTILITY FRANCHISES

Granting of Public Utility Franchises: Section 14.1. Public utility franchises and all renewals, and extensions thereof and amendments thereto shall be granted only by ordinance...
