

Bloomfield Hills Postal Jobs Open

A civil service examination for provisional appointment to positions of substitute clerk and substitute carrier at Bloomfield Hills, at \$1.61½ per hour, was announced today by J. A. Conner, Director of the Seventh U. S. Civil Service Region. Additional compensation is provided for night work and for authorized overtime. Competition in this examination is restricted to residents of Bloomfield Hills and persons now employed in the Bloomfield Hills post office, who are between the ages of 18 and 50. These age limits are waived for veterans.



PERSONS NOW holding temporary or indefinite appointments should file for this examination if they wish to be considered for permanent appointment. A written test is required of all applicants. Applications must be filed with the director, Seventh U. S. Civil Service Region, New Post Office Building, Chicago 7, Illinois, and will be accepted until the close of business on 11, 1954. Full information and application cards may be obtained at the post office.
