ORDINANCE NO. 457. City of Birmingham. AN ORDINANCE TO PROVIDE FOR THE LICENSING OF TAXICABS IN THE CITY OF BIRMINGHAM...

Section 101. PURPOSE. The following words and phrases when used in this Ordinance shall have the meanings respectively ascribed to them...

Section 102. CALL BOX. The taxicab shall have a call box which shall be maintained in good order...

Section 103. CERTIFICATE. A person applying for a license shall submit a certificate of good character...

Section 104. CRUISING. A driver of a taxicab shall not cruise in any public place of the City of Birmingham...

Section 105. DRIVER. The person operating a taxicab shall be a resident of the City of Birmingham...

Section 106. LICENSE. A permit to operate a taxicab shall be known as a license and shall be issued by the Commission...

Section 107. MANIFEST. A daily record prepared by a driver of a taxicab shall be known as a manifest...

Section 108. OWNER. The person who owns or controls a taxicab shall be known as the owner...

Section 109. PERSON. Includes an individual, partnership, and any other legal entity...

Section 110. RATE CARD. A schedule of rates for taxicab service shall be known as a rate card...

Section 111. TAXICAB STAND. A place or structure where taxicabs are available for hire shall be known as a taxicab stand...

Section 112. ADDITIONAL TAXI. The Commission may issue a special license for taxicabs to be used for special occasions...

Section 113. NUMBER OF LICENSES. The Commission shall determine the number of licenses to be issued...

Section 114. APPLICATION. An application for a license shall be filed with the Commission...

Section 115. APPROVAL. The Commission may approve or disapprove an application for a license...

Section 116. KNOWLEDGE. The applicant for a license shall be deemed to know the laws of the City of Birmingham...

Section 117. INSURANCE. The driver of a taxicab shall maintain liability insurance...

Section 118. OPERATION. The driver of a taxicab shall operate it in accordance with the license...

Section 119. RIDING WITH DRIVER. No passenger shall ride in a taxicab with the driver...

Section 120. PASSENGERS. The driver of a taxicab shall not transport more passengers than the vehicle is designed to carry...

Section 121. REMOVAL OF UNSAFE CAR. The driver of a taxicab shall not operate it if it is found to be unsafe...

Section 122. MARKING. The taxicab shall be marked with the name of the driver and the license number...

Section 123. UNLAWFUL TAXICABS. The Commission shall have the duty of closing the books on any taxicab operator who fails to comply with the Ordinance...

LAW. All drivers shall operate their taxicabs in accordance with the provisions of this Ordinance...

Section 124. LOST ARTICLES. All drivers shall be responsible for any articles or valuables left in their taxicabs...

Section 125. MAINTENANCE. All taxicabs shall be maintained in good mechanical condition...

Section 126. SMOKING. No driver shall smoke or use any tobacco product while operating a taxicab...

Section 127. LIQUOR. No driver shall transport or sell liquor in a taxicab...

Section 128. CONDUCT. No driver shall engage in any lewd or immoral conduct while operating a taxicab...

Section 129. MANIFESTS. All drivers shall maintain a manifest for each day of operation...

Section 130. TAXIMETER. All taxicabs shall be equipped with a taximeter...

Section 131. FINGERPRINTS. The driver of a taxicab shall have his fingerprints taken...

Section 132. KNOWLEDGE. The driver of a taxicab shall be deemed to know the laws of the City of Birmingham...

Section 133. INSURANCE. The driver of a taxicab shall maintain liability insurance...

Section 134. OPERATION. The driver of a taxicab shall operate it in accordance with the license...

Section 135. RIDING WITH DRIVER. No passenger shall ride in a taxicab with the driver...

Section 139. UNLAWFUL TAXICABS. The Commission shall have the duty of closing the books on any taxicab operator who fails to comply with the Ordinance...

Section 140. ENFORCING AGENCIES. The Department is charged with the enforcement of this Ordinance...

Section 141. TYPES OF STANDS. Taxicab stands may be of any type, but shall be subject to the approval of the Commission...

Section 142. CONTINUANCE OF LICENSES. All licenses shall be subject to the provisions of this Ordinance...

Section 143. PAYMENT OF TAXI. The driver of a taxicab shall be responsible for the payment of taxes...

Section 144. MISCELLANEOUS. The Commission may make such other provisions as may be necessary...

Section 145. EFFECTIVE DATE. This Ordinance shall take effect on the date of its passage...

Section 146. SEVERABILITY. If any provision of this Ordinance is held to be invalid, the remaining provisions shall remain in effect...
