

Jurists Sought To Establish Murder Charge

Persons who served on a coroner's jury 31 years ago are being sought by Oakland County officials to help establish a first degree murder charge against a man now in Jackson state prison for another killing.

Former jurists James Greer, K. B. Brown, William Tibbitt, Mark Dupleton, George Youngs and Burnett Stewart are being traced by Prosecutor Frederick C. Ziem who says records of the inquest are lost and that both coroners who conducted the inquest are dead.

THE CHARGE is planned against Saint Helm, 55, now in Jackson for the 1923 shooting of Willie Tackie. State Courtroom department officials have told Ziem that
