LEW BOARD members met for an emergency consultation on Thursday morning. All angles were exposed in the light of League policy. The ensuing decision was to go ahead on distribution after legal advice satisfied them that Nahabedian's statement was not libelous.

The League then consulted a past state board member of extensive League experience and community understanding, who could give a detached opinion because she had not been in on previous thinking.

The decision resulting from this consultation was to include a rubber-stamped statement. The opinions and statements expressed by the candidates are not necessarily those of the League or Women Voters, on all remaining copies of the voters guides to precede the candidates' statements.

THE LEW THOUGHT at that point that they had covered all aspects of the problems and that their solution was satisfactory.

However, on Friday morning, the morning that the voters guides were to go out for public distribution, the League was advised that some members of the school board and the citizens committee had met the previous evening to discuss how to counter-act what they considered to be false implications.

The decision of both the school board and the citizens committee was to urge the League to withdraw the distribution of its bulletin to the public.

A telephone poll of League board members started early Friday morning to get a decision of the board as to whether or not the League should comply with this demand.

THE DECISION of the majority of the board was "No," but that the school board and/or the citizens committee be permitted to present a statement of policy, procedure, record and other factual material at the LWV points of distribution.

The League postponed distribution of their voters guides until mid-afternoon Friday, when they received word that neither the school board nor citizens committee would avail themselves of the opportunity offered them. So distribution of the school election material proceeded.

In a letter to the Citizens Committee on Education, Mrs. Runsey explained the policies and functions of the LWV.

"We endeavor to select a question which will not only be fair to all candidates, but will also indicate to the public the kind of thinking a candidate does and his probable approach to the job for which he is campaigning.

"OUR POSITION of complete impartiality in regard to candidates would naturally preclude any editing of their opinions. We furthermore believe that editing would distort the views of the candidate.

"Although we took a stand favoring the bond issue, thus supporting the citizens committee and the school board, we had no right to prevent the freedom of speech of a candidate.

"We feel that it is a service to the public to present a candidate's own statements. We cannot justify

Two Who Took Car Here Arrested in St. Clair Shores

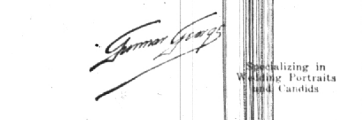
One of two youths, a 15-year-old Birmingham boy, whose police say took a car in Birmingham Tuesday, is in Detroit Juvenile home and the second is in custody
