

Council to Amend Village Charter

BINGHAM FARMS — Bingham Farms village council began action Monday night at its meeting to amend section 3, chapter 11 of its charter to allow special assessments for road improvements.

The present section reads that no construction, improvement and maintenance of highways, streets and alleys within the village that cannot be paid for wholly by state funds shall be authorized or undertaken unless first approved by two-thirds of the electors at a general meeting.

The new amendment states that the cost shall be paid for in accordance with the general laws of the state, which demand that the village equal the state fund.

Legal notice of this proposed amendment will be in The Eccentric. The matter was tabled until the January meeting.

A PUBLIC HEARING on a seven-acre plat proposed by Englehardt, Baettner and Holt, builders, will take place at the January meeting.

Because the plat, which is at the eastern limit of the village, does not meet the requirements of the zoning law, a public hearing is necessary to pass it.
