TO arrive at such a decision has taken "weighty considerations" my part and assure you that while the position calls for a substantial increase in salary, I had no major part in the final decision. The final decision was arrived at by the previously stated review of the needs of the area and consideration of present conditions within the Birmingham governmental structure.
