LEGAL NOTICE CITY OF BIRMINGHAM AN ORDINANCE TO ENFORCE AND REGULATE THE ERECTION AND MAINTENANCE OF SIGNS

Section 201 - ACCESSORY SIGNS. Every sign which is erected on a building, structure, or structure, shall be subject to the provisions of this ordinance...

Section 202 - INCOMBUSTIBLE MATERIAL. Every sign which is erected on a building, structure, or structure, shall be subject to the provisions of this ordinance...

Section 203 - SIGNS. Every sign which is erected on a building, structure, or structure, shall be subject to the provisions of this ordinance...

Section 204 - STRUCTURAL REQUIREMENTS. Every sign which is erected on a building, structure, or structure, shall be subject to the provisions of this ordinance...

Section 205 - OBSTRUCTIONS. Every sign which is erected on a building, structure, or structure, shall be subject to the provisions of this ordinance...

LEGAL NOTICE ANCHORAGE AND SUPPORT. ALL SIGNS SHALL BE PROPERLY ANCHORED AND SUPPORTED...

Section 211 - ANCHORAGE AND SUPPORT. All signs shall be properly anchored and supported in accordance with the provisions of this ordinance...

Section 212 - AREA LIMITATIONS. The total area of any sign shall not exceed the area specified in this ordinance...

Section 213 - OBSTRUCTIONS. No sign shall be erected in such a manner as to obstruct any view or passage...

Section 214 - MOUNTING. Every sign shall be mounted in accordance with the provisions of this ordinance...

Section 215 - FACING OF SIGN SHALL BE PERMITTED TO PROTRUDE IN OR ON THE BUILDING. Every sign which is erected on a building, structure, or structure, shall be subject to the provisions of this ordinance...

LEGAL NOTICE PERMIT TO ERECT SIGN. ANY PERSON WHO DESIRES TO ERECT A SIGN...

Section 221 - PERMIT TO ERECT SIGN. Any person who desires to erect a sign shall first obtain a permit from the City of Birmingham...

Section 222 - FEE. The fee for a permit to erect a sign shall be as follows...

Section 223 - EXPIRATION. A permit to erect a sign shall expire on the date specified in the permit...

Section 224 - VIOLATION. Any person who erects a sign without a permit shall be liable to a fine...

Section 225 - APPEAL. Any person who is dissatisfied with the decision of the City of Birmingham...

Section 226 - SIGNAGE. All signs shall be subject to the provisions of this ordinance...

Section 227 - OBSTRUCTIONS. No sign shall be erected in such a manner as to obstruct any view or passage...

Section 228 - MOUNTING. Every sign shall be mounted in accordance with the provisions of this ordinance...

Section 229 - FACING OF SIGN SHALL BE PERMITTED TO PROTRUDE IN OR ON THE BUILDING. Every sign which is erected on a building, structure, or structure, shall be subject to the provisions of this ordinance...

Section 230 - OBSTRUCTIONS. No sign shall be erected in such a manner as to obstruct any view or passage...
