if you're like me... Says the Barrister

You have no desire to be a witness in a lawsuit. But the day may come when your testimony may be absolutely necessary for a just verdict in some case.

I've just about come to the conclusion that I'd testify even if a subpoena had not been issued ordering me to appear.

I'll tell you why. Trials can be decided fairly only when all the truth is brought out. And the judge and jury learn of the truth from witnesses such as you or I could be in a given situation. As witnesses we would be sworn under oath "to tell the truth, the whole truth, and nothing but the truth" as to what we had seen or heard. I suppose it's a duty of citizenship to give testimony when it's required.

Frankly, that probably isn't the reason I made up my mind as I did. Nope, the reason I'll testify is because some day the shoe may be on the other foot. I may find the fate of my own case balanced on the willingness of someone to come forward and tell what he knows.

I looked up this business of testifying as a witness and found out a few things... too many things to write down in full. But here are a few examples:

**THERE ARE certain "rules of evidence."** For instance, there is the hearsay rule which prevents a witness from relating a choice piece of gossip he has heard from

Then there is the method of examining witnesses so that both sides of a lawsuit have an equal opportunity in interrogating them, that's called "direct examination" and "cross examination."

Probably the best way to get ready is to discuss your testimony in advance with the lawyer calling you in the case. He will explain courtroom procedure and proper courtroom behavior.

When I looked into this subject, I got a list of good rules to follow and I'll pass them on to you. Never lose your temper—Be attentive—Think before you speak—Speak clearly—If you don't understand a question, ask that it be explained—Answer all questions directly—Stick to the facts—Be helpful, not funny—Be fair.
