THEIR "We-can-save-taxes" platform may be in the same category as most other political oratory—platitudes designed to attract more votes in the hope of getting elected.

This newspaper has regularly covered and reported on the township's meetings and other affairs. Our knowledge of the township's present handling convinces us that funds are efficiently and economically handled.

This is why we recommend the re-nomination of Hulet, Case and Dudley.

We believe all of the nine candidates for township trustee appear to be pretty well qualified. We therefore feel no specific endorsement is called for.
