

Major State X-Ways To Get New Numbers

(This article reprinted from the February 1959 "High-Lighter," Michigan State Highway Department Publication.)

New route numbers approved by the U.S. Bureau of Public Roads and the American Association of State Highway Officials for the National interstate highway system will start appearing in Michigan during 1959 on portions of the system completed and up to standard.

Michigan has over 180 miles of such routes currently open to traffic.

Until the routes are completed from border to border, current plans call for a dual-type signing to acquaint the motorist with the new designations and still retain former designations with which the motoring public is familiar.

MAJOR CHANGES include:

- 1) US-12, from Detroit to Chicago, will become Interstate 94, as will its northeast extension (US-25) to Port Huron.
- 2) US-16, from Detroit to Grand Rapids, will become Interstate 96, and the route from Grand Rapids

to Holland and south to Interstate 94 near Benton Harbor will also be designated Interstate 96. The route from Grand Rapids to Muskegon will become Interstate 196.

3) The Detroit-Toledo expressway (US-24A) into downtown Detroit and its extension from Detroit north (vicinity of US-10) to Flint, north (vicinity of US-23) to Standish, westerly to the vicinity of Grayling, north to the Mackinac bridge (vicinity of US-27), and north (US-2) to Sault Ste. Marie, will become Interstate 75.

4) A new expressway from Interstate 94 (US-12) near Marshall south to the Indiana line will be designated Interstate 69.

5) In the Detroit area, the future beltline expressway in the vicinity of 10- and 11-Mile rds. from near Mt. Clemens west to Brighton-Farmington expressway (Interstate 96) will be designated 696, and from the Brighton-Farmington expressway south to the vicinity of Monroe, Interstate 275.

6) Urban connections of the expressway system with the following towns will have the following designations: Interstate 94 with downtown Battle Creek will be Interstate 194; Interstate 96 with Lansing, Interstate 696; Interstate 96 with Grand Rapids, Interstate 296; Interstate 75 with Flint, Interstate 475; and Interstate 75 with Interstate 675.

HIGHWAY Department plans call for the first installation of Interstate signing on the Brighton-Farmington expressway early this year and dual signing (which will include the Interstate designations as well as former designations) on the remainder of completed sections on the system at a later date. Plans are also being formulated to have the dual signing erected on all new sections when they are opened to traffic.

The new signs (shield-type silhouette design) will vary in size from 24 to 48 inches and will have a red horizontal strip at the top of the shield and the larger low section painted blue. The sign is reflectorized with white lettering.

There are some 1,000 miles on Michigan's Interstate Highway system and the national timetable for completion of the system is now from 15 to 16 years. It is expected that most of Michigan's Interstate mileage will be completed under contract by 1966.
